### Set up with your phone or tablet

The free Fitbit app is compatible with more than 200 devices that support iOS, Android, and Windows 10 operating systems.

To get started:

1. Find the Fitbit app in one of the locations below, depending on your device. If you're unsure if the Fitbit app is compatible with your phone or tablet, see <http://www.fitbit.com/devices>.
  - Apple App Store for iOS devices such as an iPhone or iPad.
  - Google Play Store for Android devices such as the Samsung Galaxy S6 and Motorola Droid Turbo 2.

The method provided by the Accused Product involves coupling the web-enabled wireless phone (the Fitbit Versa) via “syncing,” which provides exercise-related information:

## Sync data to your Fitbit account

Regularly sync Versa with the Fitbit app to transfer data to your dashboard. The dashboard is where you'll track your progress, see exercise history, track activity patterns, log food and water, identify trends, participate in challenges and more. We recommend syncing at least once a day.

The Fitbit app uses Bluetooth Low Energy technology to sync data with Versa to update apps installed on your watch.

Each time you open the Fitbit app, Versa syncs automatically when it's connected. Versa also syncs with the app periodically if All-Day Sync is on. To turn on this feature:
