The method provided by the Accused Product involves coupling the web-enabled wire (the Fitbit Versa 2) via “syncing,” which provides exercise-related information:

## See your data in the Fitbit app

Sync Versa 2 to transfer your data to the Fitbit app, where you can view your activity and sleep data, log food and water, participate in challenges, and more. For best results, keep all-day sync turned on, so that Versa 2 syncs periodically with the app. All-day sync is required for certain features on Versa 2, such as Amazon Alexa.

### WHAT IS SYNCING?

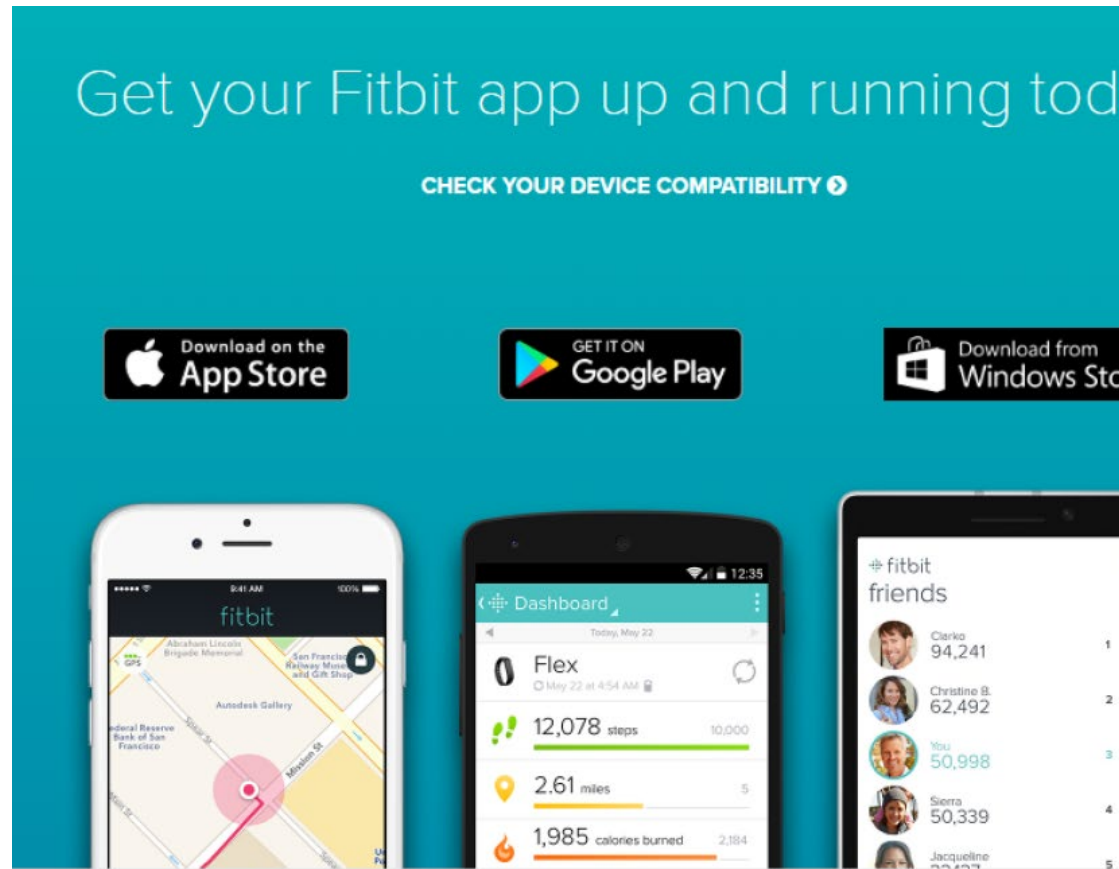
**Syncing** is the process that transfers the data your device collects to your Fitbit dashboard, where you can track your progress, see how you slept, set goals, log food and water, and much more. Fitbit trackers, watches, and Fitbit Aria Air use Bluetooth Low Energy (BLE) to sync with phones, tablets, and certain computers. Fitbit Aria and Fitbit Aria 2 use Wi-Fi to sync with your router. The instructions in [How do I set up my Fitbit device?](#) explain how to make sure your device syncs to your Fitbit dashboard.
