**STATUS UPDATE OF *INTER PARTES* REVIEW (IPR)
POST-GRANT PROCEEDINGS**

Defendants Volkswagen Group of America, Inc., Volkswagen Group of America Chattanooga Operations, LLC, and Mercedes-Benz USA, LLC notify the Court of an update to the status of the *inter partes* review (“IPR”) petitions filed before the United States Patent and Trademark Office’s Patent Trial and Appeal Board (“PTAB”). As discussed during the November 28, 2022 status conference, Volkswagen Group of America, Inc. had (at that time) filed IPR petitions on five of the six patents asserted by Neo Wireless, LLC, Mercedes-Benz USA, LLC had filed an additional IPR petition, and Volkswagen Group of America, Inc. was in the process of preparing an IPR petition on the sixth patent—United States Patent Number 8,467,366. Volkswagen filed the IPR petition on the sixth patent on Friday.

Below is an updated summary of the IPR proceedings filed on the patents asserted in this litigation by Neo Wireless, LLC. Also provided below is a listing of anticipated dates for any institution decisions by the PTAB.

Volkswagen and Mercedes-Benz will promptly advise the Court on the status of any resulting institution decisions once they are made by the PTAB.
