This firm, together with Paul Hastings LLP and Loeb & Loeb LLP, represents Plaintiffs in the above-referenced matter. We write jointly with defendants Teva Pharmaceuticals USA, Inc. and Teva Pharmaceutical Industries, Ltd. (collectively, "Teva") to request an adjournment of the Rule 16 conference scheduled for March 29, 2016 (D.I. 17) and a stay of this matter pending the results of Teva's appeal in a related action.

As Your Honor is aware, the parties to this action were also parties to Civil Action No. 11-3962, which resulted in a Final Judgment in favor of Plaintiffs on November 13, 2015.
