THIS MATTER having been brought before the Court upon the application of Defendants' GAIN Capital Holdings, Inc. and GAIN Capital Group, LLC ("GAIN"), by and through their attorneys, for an Order granting GAIN leave to amend its invalidity contentions in response to OANDA Corporation's ("OANDA") newly amended infringement contentions pursuant to Local Patent Rule 3.7; and the Court having considered the papers submitted in support of the related application; and the Court having considered that OANDA does not object to the amendment requested herein; and the Court having further found that the standards of Local Patent


Rule 3.7 have been met and support the amendment of GAIN's invalidity contentions, including that GAIN's application is timely and good cause exists for the requested amendment herein; and the Court having considered the status of these proceedings and the pleadings of record; and for the reasons set forth in the record of the proceedings, and for other good cause having been shown,

ORDERED that GAIN's application, pursuant to Local Patent Rule 3.7, for leave to amend its invalidity contentions is **GRANTED**; and it is further

ORDERED that GAIN may serve its Amended Invalidity Contentions within five (5) business days of the date of receipt of this Order.

ORDERED that OANDA may serve its Amended Responses to Invalidity Contentions responding to any new contentions raised in GAIN's Amended Invalidity Contentions pursuant to L. Pat. R. 3.4A within fourteen (14) days of the date of service of GAIN's Amended Invalidity Contentions.
