

AND UPON the application of Clearwater Capital Partners ("CCP") for an adjournment of the PL Application (the "Adjournment Application")

AND UPON hearing Leading Counsel for CSI and Tianrui (International) Holding Company Limited ("Tianrui"); Counsel for the Company; Counsel for Taconic Opportunity Master Fund LP ("Taconic"), Claren Road Asset Management LLC and ASM Connaught House Fund LP; Counsel for CCP; and Counsel for Asia Cement Corporation

AND UPON reading the Affidavits listed in the Schedule attached hereto

IT IS ORDERED that:



- 1 The Petition be struck out.
- 2 The PL Application be dismissed.
- 3 The Inspector Application be withdrawn.
- 4 The Adjournment Application be withdrawn.
- 5 The costs of CSI and Tianrui be paid by the Company as follows:
 - (a) the costs arising out of and incidental to the Petition and the PL Application incurred up to and including 11 November 2015 (Cayman Islands time) to be taxed on the standard basis if not agreed; and
 - (b) the costs arising out of and incidental to the CSI Summons, the Petition and the PL Application incurred from and including 12 November 2015 (Cayman Islands time) to be taxed on the standard basis if not agreed but, in assessing such costs, one set only is to be allowed.
- The costs of Taconic arising out of and incidental to the Petition and the PL Application incurred up to and including 11 November 2015 (Cayman Islands time) be paid by the Company, to be taxed on the standard basis if not agreed.
- The costs of CCP arising out of and incidental to the Petition and the PL Application incurred up to 11:00 a.m. on 18 November 2015 (Cayman Islands time) be paid by the Company, to be taxed on the standard basis if not agreed.
