Counsel for Petitioner indicated that if Patent Owner is granted an opportunity to respond to Petitioner's Request for Rehearing, then Petitioner requests the opportunity to respond to Patent Owner's Request for rehearing.

The Board authorized both Petitioner and Patent Owner to respond to the opposing party's Request for Rehearing.

ORDERED that Patent Owner is authorized to file a response, limited to 3 pages, by March 28, 2014, to Petitioner's Request for rehearing (Paper 73); and
