PATENT OWNER'S REQUEST FOR ORAL ARGUMENT

In accordance with 37 C.F.R. § 42.70(a), Patent Owner Versata Development Group Inc. respectfully requests the opportunity to present oral arguments before the PTAB on May 28, 2014. (See Scheduling Order, Paper No. 9, p. 5). The issues to be argued include the patentability of the claims under § 101, Patent Owner's Motion to Amend, Patent Owner's Motion to Exclude, any other issues briefed by or presented by the parties throughout this trial, and any issues argued by Petitioner during the oral argument.

Though prior PTAB orders indicate a desire to consolidate oral argument time for reviews involving the same parties, Patent Owner respectfully requests separate oral argument time for the instant proceeding and CBM2013-00018. The proceedings involve two different patents with completely different specifications, completely different claim sets, and highly distinct factual issues. Accordingly, Patent Owner believes separate oral argument time to be warranted in this proceeding. Further, given the newly-presented issues included in Petitioner's Reply and Exhibits 1017 and 1018, Patent Owner respectfully requests 90 minutes time for oral argument.
