**PETITIONER'S REQUEST FOR REFUND**  
**OF POST-INSTITUTION FEES**

Petitioner Volusion, Inc. (“Volusion”) requests a refund in the amount of \$1,650.00 to be paid to account number 160605 pursuant to the U.S. Patent and Trademark Office’s Final Rule Setting and Adjusting Patent Fees, 78 F.R. 4211, 4234-35 (Jan. 18, 2013).

On April 23, 2013, Volusion filed a Petition for Post-Grant Review of a Covered Business Method Patent with the PTO that was assigned case number CBM2013-00017. In accordance with the fee schedule specified in 37 C.F.R. § 42.15(b), Volusion deposited an electronic payment in the amount of \$35,150 with the PTO at the time of filing its Petition to cover associated fees for claims 1-23. Volusion’s payment consisted of \$12,750 in fees associated with Volusion’s Covered Business Method Patent Review request, and a further \$22,400 in Post-Institution fees.

On October 24, 2013, the Patent Trial and Appeal Board entered a Decision to only institute claims 1-20, not all 23 as requested. The Final Decision was issued in this proceeding on June 17, 2014. Accordingly, Volusion requests a refund in the amount of \$1,650.00 for the post-institution fees that it has paid to the USPTO in connection with claims 21, 22, and 23 in that proceeding.
