On October 3, 2013, a conference call was held involving counsel for the respective parties and Judges Blankenship, Medley and Turner. The purpose of the call was to inquire why the Patent Owner has not filed its mandatory notices in compliance with 37 C.F.R. § 42.8, which are past due for the proceedings. Mr. Chambers indicated that he would be lead counsel for Patent Owner in the three proceedings. Mr. Chambers indicated that Patent Owner would comply and file the mandatory notices shortly. As further discussed, the time for filing an opposition to any of Petitioner's motions for *pro hac vice* is also due at that time.

It is

ORDERED that Patent Owner shall, no later than October 7, 2013, file its mandatory notices in accordance with 37 C.F.R. § 42.8;

FURTHER ORDERED that no filings on behalf of Patent Owner will be accepted by the Board until the required mandatory notices have been filed;

FURTHER ORDERED that Patent Owner's oppositions to any of Petitioner's motions for *pro hac vice* admission are also due October 7, 2013.
