**JOINT REQUEST TO KEEP SEPARATE PURSUANT TO 35 U.S.C. §  
327(b) AND 37 C.F.R. § 42.74**

Patent Owner and Petitioner (together, "the Parties"), have reached a settlement and executed a Reseller Agreement regarding U.S. Patent No. 7,908,304 ("the '304 Patent"). A *true copy of* the Reseller Agreement is filed concurrently herewith as Exhibit 2018.

I. **Statement of Precise Relief Requested**

The Parties jointly request that the Board treat the Reseller Agreement (Exhibit 2018) as business confidential information, keep it separate from the file of the involved patent, and made available only to Federal Government agencies on written request or to any person only on a showing of good cause, as provided for in 35 U.S.C. § 327(b) and 37 C.F.R. § 42.74.

II. **Statement of Reasons for the Relief Requested**

The Parties have executed a Reseller Agreement regarding their disputes relating to the '304 Patent. The Reseller Agreement addresses this covered business method review, as well as disputes regarding the '304 Patent involved in *Versata Software, Inc. et al. v. Callidus Software Inc.*, No. 1:12-cv-931-SLR (D. Del.). The Reseller Agreement provides that the terms of the Reseller Agreement are confidential.

Patent Owner has filed, concurrently herewith, a copy of the Reseller Agreement (Exhibit 2018) with the Board, as required by 35 U.S.C. § 327(b) and 37 C.F.R. § 42.74. Exhibit 2018 was filed in the PRPS system to provide

availability to "Parties and Board Only." The Parties jointly request that the Reseller Agreement be treated as business confidential information and be kept separate from the file of the involved patent, pursuant to 35 U.S.C. § 327(b) and 37 C.F.R. § 42.74(c).
