Independent Software Vendor (“ISV”)

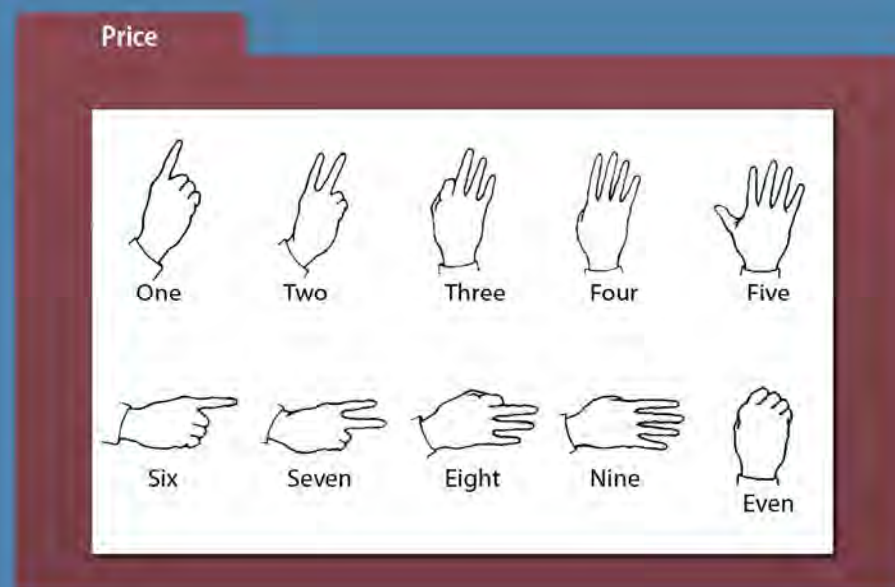
- Sells electronic trading software

In the mid 1990s, almost all futures were traded face to face in trading “pits” called “open outcry”

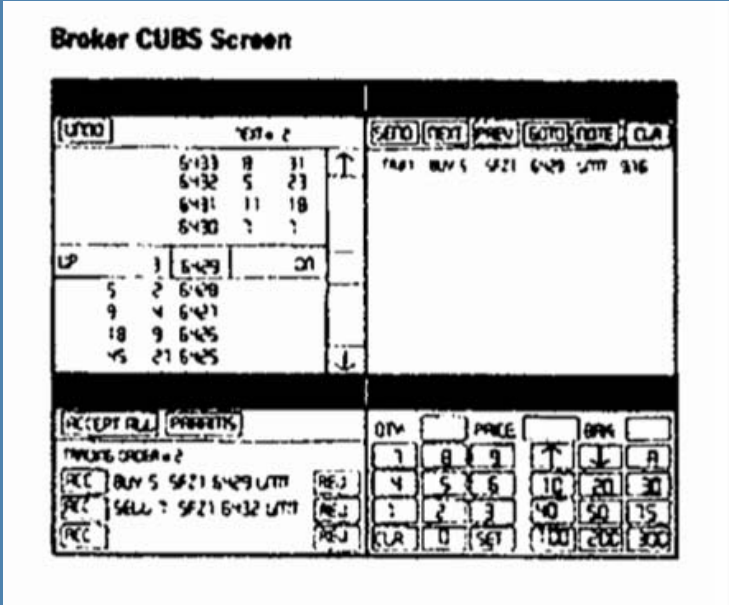

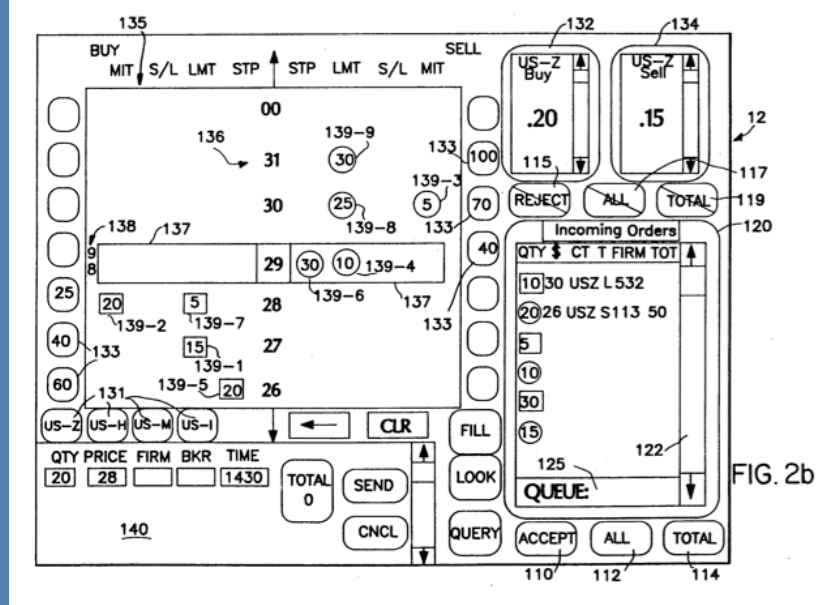
