INTRODUCTION

During a telephone conference on June 30, 2015, when the parties informed the Board of their settlement, the Board authorized the parties to file a joint motion to terminate these proceedings and a joint request that the settlement agreement be treated as business confidential information and kept separate. In a motion filed concurrently herewith, Petitioner and Patent Owner jointly request termination of these proceedings. The parties also submit, as part of that joint request, a true copy of the agreement between them (the "Agreement") as Exhibit 2300.
