**PATENT OWNER'S REQUEST FOR ORAL HEARING**

The Board has already scheduled oral hearings for this CBM proceeding (CBM2014-00137) and the three other pending CBM proceedings between Petitioners and Patent Owner (CBM2014-00131, CBM2014-00133, and CBM2014-00135) for July 9, 2015. Paper 20 at 6. Pursuant to 37 C.F.R. § 42.70(a), Patent Owner requests oral hearing on the instituted grounds of unpatentability in each of the proceedings as well as all motions to exclude filed in the proceedings. Given the overlapping issues in the proceedings, Patent Owner proposes scheduling argument of the issues as follows:

- 9:00am – Whether U.S. Patent Nos. 6,772,132 and 7,676,411 qualify for CBM review, whether claims 1-56 of the '132 patent are patentable under 35 U.S.C. § 101, and whether claims 1-28 of the '411 are patentable under 35 U.S.C. § 101 (each side gets 90 minutes)
- 12pm – 60 minute lunch break
- 1:00pm – Any motions to exclude filed by Petitioners (each side gets 10 minutes)
- 1:30pm – Any motions to exclude filed by Patent Owner (each side gets 10 minutes)
- 2pm – Whether U.S. Patent No. 7,685,055 qualifies for CBM review, whether claims 1-19 of the '055 patent are patentable under 35 U.S.C. § 101, whether claims 1, 3, 4, 6-15, and 17-19 of the '055 patent are

patentable under 35 U.S.C. § 103 over TSE, and whether claims 2 and 5 of the '055 patent are patentable under 35 U.S.C. § 103 over TSE and Gutterman (each side gets 60 minutes)

- 4:15pm – Whether U.S. Patent No. 7,533,056 qualifies for CBM review, whether claims 1-15 of the '056 patent are patentable under 35 U.S.C. § 101, and whether claims 1-15 of the '056 patent are patentable under 35 U.S.C. § 103 over TSE, Togher, and Schott (each side gets 60 minutes)

Patent Owner requests that, in addition to lead and back-up counsel, eight spaces be reserved at the oral hearings to accommodate its counsel and corporate representatives.
