Pursuant to 37 C.F.R. § 42.8 and in accordance with the Board's Order dated January 29, 2015 (Paper No. 9), JP Morgan Chase & Co. and JP Morgan Chase Bank, N.A. ("Petitioner") submit the following Updated Mandatory Notice.

In a complaint dated October 1, 2012 (Ex. 1010), U.S. Patent No. 5,949,880 ("the '880 Patent") was asserted against Petitioner in the action captioned *Maxim Integrated Prods., Inc. v. JP Morgan Chase & Co.*, No. 2:12-cv-01641-JFC (W.D. Pa.) ("JPMC Litigation"). This action was consolidated into the multidistrict litigation described below. On October 20, 2014, the Court entered an order (Ex. 1017) dismissing with prejudice all claims against Petitioner relating to the '880 Patent, and dismissing without prejudice Petitioner's affirmative defenses relating to the '880 Patent.

To Petitioner's knowledge and understanding, the '880 Patent has also been asserted in 26 other cases consolidated into multidistrict litigation as *In re: Maxim Integrated Prods., Inc.*, MDL No. 2354, Misc.
