1. Motion to Compel Routine Discovery

Patent Owner anticipates filing a Motion to Compel Routine Discovery to compel the production of Apple’s litigation filings and reports relating to non-infringement and non-infringing alternatives that should have been served by Petitioner Apple concurrently with its Corrected Petition under to 37 CFR § 42.51(b)(1)(iii).

2. Motion to Permit Coordination of Deposition Transcripts

Petitioner filed a declaration in this proceeding and in multiple other proceedings by the same declarant, Mr. Anthony J. Wechselberger. Patent Owner anticipates filing a Motion to Permit Coordination of Deposition Transcripts, if necessary, seeking the Board’s permission (as was permitted in earlier CBM proceedings on patents in the same patent family) to allow a single deposition to be
