PETITIONER GOOGLE INC.'S NOTICE OF APPEAL

Pursuant to 35 U.S.C. §§ 141, 142, and 319, and in accordance with 37 C.F.R. §§ 90.2-.3, Petitioner Google Inc. (“Google”) appeals to the United States Court of Appeals for the Federal Circuit from the Final Written Decision of the Patent Trial and Appeal Board (“Board”) entered on June 21, 2016 (Paper No. 34) (“Final Written Decision”) in CBM2015-00040² and from all underlying findings, determinations, rulings, opinions, orders, and decisions regarding the covered business method reviews of U.S. Patent No. 7,774,280 (“ ’280 patent”). Copies of the Final Written Decisions are attached. Petitioner Apple Inc. is also filing a notice of appeal in this matter.

In accordance with 37 C.F.R. § 90.2(a)(3)(ii), Google states that the issues on appeal include, but are not limited to: the Board’s determination that substitute claim 37 and any dependent claims of the ’280 patent are patentable; the Board’s construction of those claims; the Board’s determination that substitute claim 37 of the ’280 patent is “substantially identical” to original claim 1; the Board’s consideration of the expert testimony, prior art, and other evidence in the record; the Board’s factual findings conclusions of law or other determinations supporting or related to those issues, as well as all other issues decided adversely to Google in any orders, decisions, rulings, and opinions.
