

Patent Owner sets forth below, in its Preliminary Response, why no Covered Business Method (CBM) review should be instituted for the patent-at-issue. Arguments presented herein are presented without prejudice to presenting additional arguments in a later response should the PTAB institute a CBM review.

#### I. OVERVIEW OF U.S. PATENT NO. 8,336,772

#### A. Background of U.S. Patent No. 8,336,772

Although the claims define the actual scope of coverage of the patent, as described in the first paragraph of the BACKGROUND OF THE INVENTION, the patent-at-issue, U.S. Patent No. 8,336,772 (hereinafter "the '772 patent") generally describes "data storage and access systems ... [and] is particularly useful for managing stored audio and video data, but may also be applied to storage and access of text and software, including games, as well as other types of data." Col. 1, lines 23-31.

Preferred embodiments described in the paragraph crossing cols. 15 and 16 illustrate this further: "FIG. 7 ... shows a variety of content access terminals for accessing data supply computer system 120 over internet 142. The terminals are provided with an interface to a portable data carrier or 'smart Flash card' (SFC) as generally described with reference to FIG. 2 and as described in more detail below. In most embodiments of the terminal the SFC interface allows the smart Flash card
