2 A. Yes.

3 Q. Could you start by giving us a brief  
4 rundown of your educational background; I think after  
5 secondary school.

6 A. I went to Washington University in  
7 St Louis. From graduating in '93 I have a Bachelors in  
8 Political Science with Economics minor and I have taken  
9 some IT courses at De Paul.

10 Q. The IT courses at De Paul followed your  
11 education at Washington University?

12 A. Yes.

13 Q. How many classes did you take at De Paul?

14 A. Two.

2 Q. After your graduation from Washington  
3 University, can you tell me a little bit about your  
4 work history?

5 A. Sure. I worked on the family farm for a  
6 while in West Chicago, Illinois, and then in July of  
7 1994 began working for MJM Trading, which was  
8 associated with Marquette Partners. I clerked on the  
9 floor and then did system trading and programming  
10 upstairs concurrently.

11 In 1995 I began working half my time and  
12 half my salary was paid for by Marquette Partners in  
13 working with their traders and their IT staff,  
14 basically doing trader support as well as trading  
15 off-the-floor systems for them.

16 In 1996 I went full time with Marquette in  
17 Marquette Electronic Brokerage, which was a brokerage  
18 unit that they had formed. At that point I did IT as  
19 well as brokering and clearing in back office. As well  
20 as continuing doing trader support for Marquette, the  
21 main company.

22 In 1998 I began doing IT full-time for  
23 Marquette. In September of '98 I came to Europe, to  
24 their Frankfurt offices, their Paris offices and their  
25 London offices for about eight weeks.
