1 JUDGE PETRAVICK: Good morning.

2 MS. GORDON: Good morning.

3 JUDGE PETRAVICK: This is Judge  
4 Petravick. With me on the telephone are Judges  
5 Medley and Plenzler. We're here for CBM2015-00179,  
6 '181, and '182.

7 I understand there is a dispute about  
8 the length of a deposition. We got an e-mail from  
9 the Petitioner.

10 Petitioner, could you tell us who's  
11 on the line for you?

12 MS. GORDON: Yes, Your Honor. This  
13 is Lori Gordon from Sterne Kessler. I'm here with  
14 Rob Sokohl, and I'm going to be presenting on behalf  
15 of the Petitioners today.

16 JUDGE PETRAVICK: Okay.

17 And for the Patent Owner?

18 MS. EMSLEY: Good morning, Your  
19 Honor. This is Rachel Emsley for the Patent Owner,  
20 and with me is Josh Goldberg.

21 JUDGE PETRAVICK: Is there anybody  
22 else on the line?

23 THE COURT REPORTER: Your Honor, good  
24 morning. This is Susan, the court reporter.

25 JUDGE PETRAVICK: Thank you.

1                   And who arranged for the court  
2 reporter?

3                   MS. GORDON: Petitioners did, Your  
4 Honor.

5                   JUDGE PETRAVICK: And you'll file the  
6 transcript afterwards?

7                   MS. GORDON: Yes, we will.

8                   JUDGE PETRAVICK: Thank you.

9                   Petitioner, since you sent us the  
10 e-mail, we'll hear from you first.

11                   MS. GORDON: Okay. Thank you, Your  
12 Honor.

13                   There are actually three topics that  
14 we'd like to raise with the Board today.

15                   The first, since Mr. Kawashima is a  
16 Japanese resident, his native language is Japanese,  
17 we believe that he is going to be interested in  
18 requesting a translator for the deposition.

19                   In accordance with Rule 4253, there's  
20 an indication that we needed to initiate a  
21 conference call with the Board before the deposition  
22 on that.

23                   I don't know if the panel would like  
24 us to initiate another conference call when we  
25 confirm that an interpreter would be needed or if we

1 can consider this as our call on the interpreter  
2 issue.

3 JUDGE PETRAVICK: Does the Patent  
4 Owner object to a translator? Would the Patent  
5 Owner object to a translator?

6 MS. EMSLEY: No, we wouldn't object.  
7 If there is a translator, we will have a check  
8 translator.

9 JUDGE PETRAVICK: That's fine.  
10 Then we would consider this your  
11 conference call.

12 MS. GORDON: Okay. Thank you, Your  
13 Honor.

14 The second issue that we wanted to  
15 get guidance on related to handling any issues that  
16 might arise during the deposition.

17 The process of getting Mr. Kawashima,  
18 who's a Japanese resident, to agree to another  
19 deposition on this matter has been quite difficult  
20 and he recently agreed to be deposed in the  
21 continental U.S. and that actually removes a lot of  
22 the travel burden on both parties, including the  
23 Patent Owner.
