**PETITIONER'S REQUEST FOR REFUND OF POST-INSTITUTION FEES

On January 8, 2016, Apple Inc. (“Petitioner”) filed a Petition for *Covered Business Method* Review of US. Patent No. 6,411,941 under 35 U.S.C. § 321 and § 18 of the Leahy-Smith America Invents Act (Petition, Paper No. 1), seeking *Covered Business Method* review of claims 1-19 of the '941 patent. On April 22, 2016, Petitioner and Patent Owner filed a Joint Motion to Terminate with Request to Keep Separate (Paper 6). On April 26, 2016, the Patent Trial and Appeal Board issued its Judgment (Paper No. 7) to terminate the proceeding.
