**REQUEST FOR REFUND OF POST-INSTITUTION
FEE**

Apple Inc. (“Petitioner” or “Apple”) hereby files its request for a refund of the \$40,975 post-institution fee that was previously paid.

On April 12, 2018, Petitioner filed a petition for covered business method review of U.S. Patent No. 8,856,539 and paid the USPTO a total of \$63,725 at the time of filing, which included a \$40,975 payment for the post-institution fee required under 37 C.F.R. §42.15(b)(1)-(2). The filed covered business method review petition was denied institution on September 13, 2018. (Paper 10.)

Petitioner is entitled to request a refund of the post-institution fee that was previously paid and is entitled to this refund. *See e.g.*, 78 Fed. Reg. 4233 (Jan. 18, 2013) available at <http://www.gpo.gov/fdsys/pkg/FR-2013-01-18/pdf/2013-00819.pdf> (stating that “[t]he entire post-institution fee would be returned to the petitioner if the Office does not institute a review.”).

For at least the reasons set forth above, Apple respectfully requests a refund of the \$40,975 post-institution fee previously paid by Apple.
