**NOTICE OF JOINT STIPULATION AND AUTHORIZED REQUEST  
TO MODIFY TRIAL DUE DATE 4**

On December 3, 2018, the Board issued a Scheduling Order (Paper 9) in this proceeding. Petitioner Apple, Inc. (“Petitioner”) and Patent Owner Universal Secure Registry, LLC (“Patent Owner”) conferred and jointly agreed to modify DUE DATE 4 by two days (from July 17, 2019 to July 19, 2019) to match the date in two related proceedings, IPR2018-00812 and CBM2018-00024 (which are scheduled for oral argument on the same day as this proceeding).
