PATENT OWNER'S SECOND OBJECTION TO EVIDENCE

In accordance with Bd. R. 42.64, patent owner objects to Exhibit 1012 (Declaration of A. Bruce Buckman, Ph.D. ... Directed to the Proposed Substitute Claims) and Exhibit 1013 (Reply Report of Dr. A. Bruce Buckman), because they are incomplete. Each declaration purports to rely on figures said to be included in the body of the declaration when in fact the figures are missing, contrary to Fed. R. Evid. 106, 705; Bd. R. 42.61-62, 42.65.

As filed and served on September 12, 2013, Xilinx Ex. 1012 is missing twenty-one figures on pp. 19, 21, 23, 24, 25, 26, 27, 29, 31, 32, 34, 42, 43, 45, 46, 48, 49, 51, 53, 54, and 56.

Xilinx Ex. 1013, as filed and served on September 12, 2013, is missing a figure on page 16.

This objection is being timely served within five business days of service of evidence to which the objection is directed, in accordance with Bd. R. 42.64(b)(1). That is, the Xilinx evidence was filed and served on Thursday, September 12, 2013. This objection is being filed and served four business days afterwards, that is, on Wednesday, September 18, 2013.
