PREAMBLE

Be it known that I, Nouri E. Hakim, have invented a new, original, and ornamental design for a DRINKING CUP, of which the following is a specification.

The priority of all of those prior applications is claimed, all of which are fully incorporated herein by reference.

SPECIFICATION

Figure 1 is a front view of the drinking cup of the present invention;

Figure 2 is a left side view of the drinking cup shown in Figure 1, with the right side view being a mirror image thereof;

Figure 3 is a top view of the drinking cup shown in Figures 1-2;

Figure 4 is a bottom view of the drinking cup shown in Figures 1-3;

Figure 5 is a back view of the drinking cup shown in Figures 1-4.

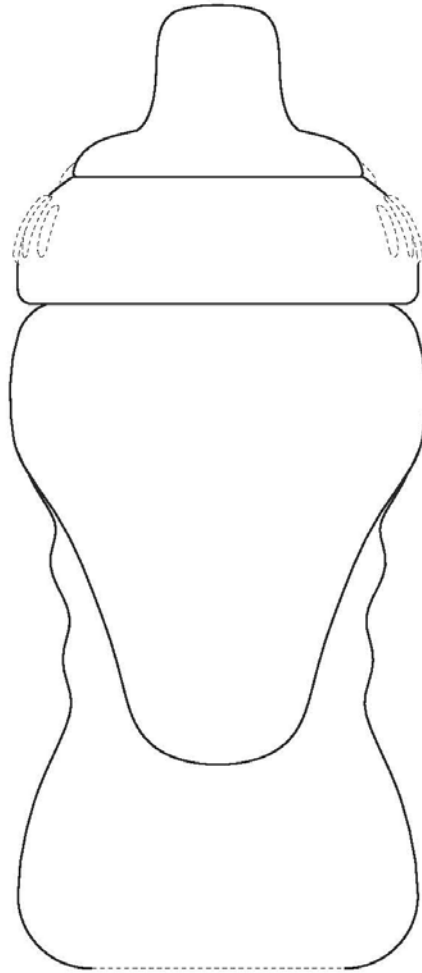
