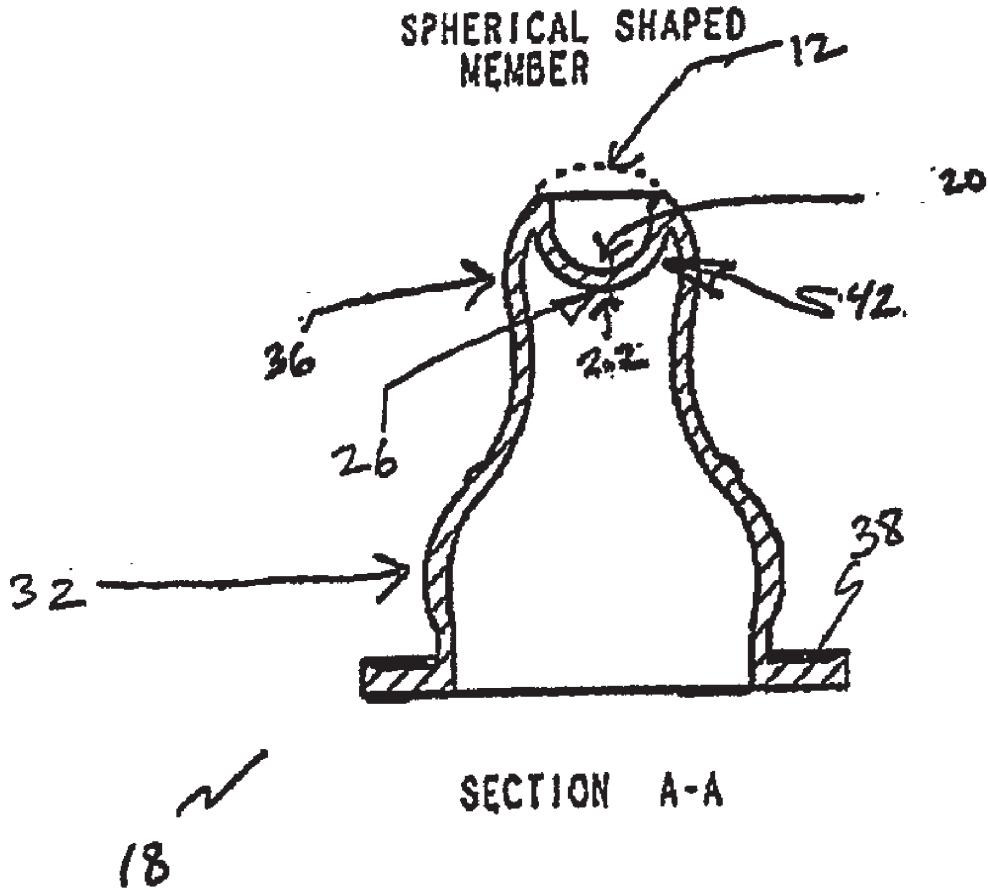

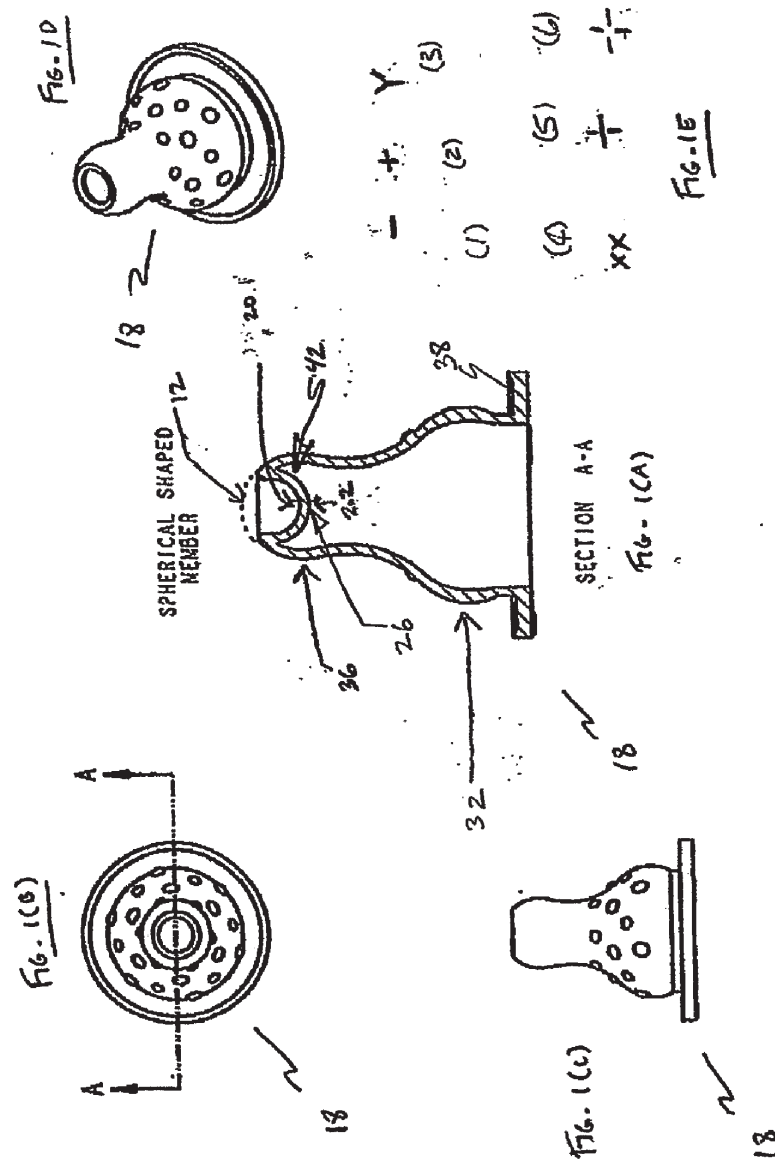

(57) **ABSTRACT**
Improved no-spill drinking products including a nipple or soft spout having a valve incorporated therein. 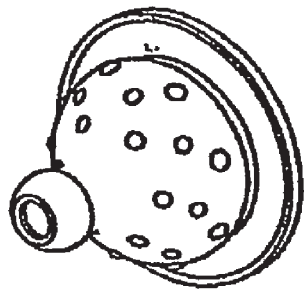

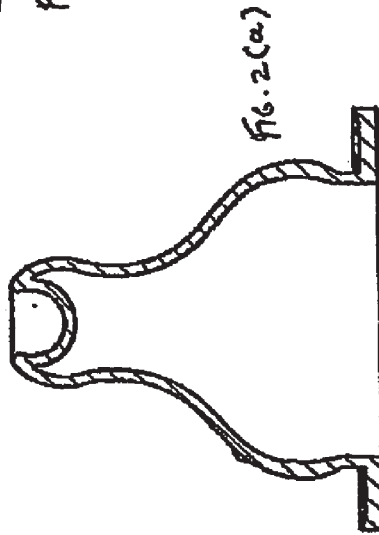

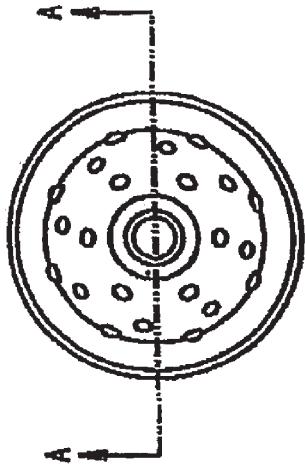
