3. The following is an examiner's statement of reasons for allowance:

The prior art of record fails to disclose or suggest a metallized composite comprising a first thermoplastic layer, an intermediate discontinuous layer comprising discrete islands of metal embedded within an adhesive layer, and a second thermoplastic layer. Specifically, KURFMAN ET AL '619 and '822 fail to disclose a laminate containing a discontinuous metal layer, while WO 96/33026 and EP 0 358 445 and EP 0 616 906 and EISFELLER '871 each fail to disclose thermoplastic laminates containing a discontinuous metal layer comprising metal particles embedded within an adhesive layer which lies between two thermoplastic sheets.

Any comments considered necessary by applicant must be submitted no later than the payment of the issue fee and, to avoid processing delays, should preferably accompany the issue fee. Such submissions should be clearly labeled "Comments on Statement of Reasons for Allowance."


