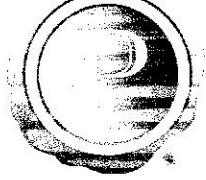



We wholeheartedly encourage people who are interested in the engineering and technological aspects or in the psychological, philosophical, socioeconomic aspects relating to virtual city such as engineering, physics, economics, psychology, philosophy, and art to join our Study Committee.

The Virtual City Study Committee is a stage for the interdisciplinary study of network community functions thought to be effective areas of application in order to boost the activities of the Virtual Reality Society of Japan.

About the future activities of the Virtual City Study Committee

The Virtual City Study Committee regularly holds Virtual City Study Committee Meetings at which committee members engage in presentations, discussions, problems, and the like encountered in this field.

Also, a Virtual City Study Specialist Committee has been formed, and in addition to managing the Virtual City Study Committee, it cooperates, from the viewpoint of the fields and areas of virtual city, in activities such as the the national conference and journal of the Virtual Reality Society of Japan, its ruling body.

Also, there are plans to consider future publications on the internet.

In fiscal 1997, four committee and specialist committee meetings are planned for the year.
