  - e. Claims 17-19 are not obvious under 35 U.S.C. § 103(a) over *Lehr*, *Cockrell, Kristiansen, Slup*, and *Streich*.
  - f. Claim 20 is not obvious under 35 U.S.C. § 103(a) over *Lehr*, *Cockrell, Kristiansen, Slup, Streich*, and *McKeachnie*.
