Based on the instructions in the Board's April 11, 2013 order, MEGCO has prepared an updated Exhibit 1025 containing a converted version of the Baker



Hughes video in a compliant MPEG format. Together with the electronic submission of this MEGCO is accordingly resubmitting an updated CD of Exhibit 1025 in MPEG format via Express Mail. MEGCO requests that the Board accept resubmitted Exhibit 1025 and grant its Motion to Accord a filing date of April 2, 2013.
