DECLARATION

7. Some of the bundled Windows NT 3.5 Server packages I saw in fall of 1994 included a printed copy of Windows NT TCP/IP Guide.
8. In fall of 1994 for personal training purposes I purchased a retail copy of Windows NT 3.5 Server.
9. I still have the original box for Windows NT 3.5 Server and its original contents. I have decided to keep it to be able to support legacy systems.

11. I compared the digital copy of the Windows NT Server retail TCP/IP Guide on the CD-ROM to Exhibit 1004 in the above referenced Case, No. IPR2013-00246. The two documents are substantially identical.

12. The digital copy of the Windows NT Server retail TCP/IP Guide contains the same 1994 copyright date as Exhibit 1004.

13. I gave the box and its contents to Paul Haughey, the Sipnet counsel.

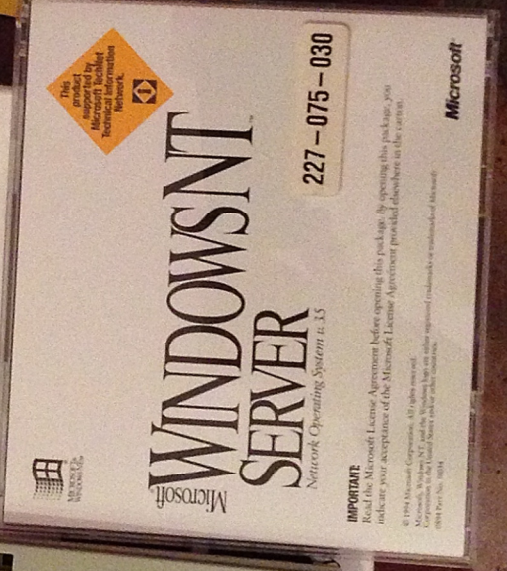
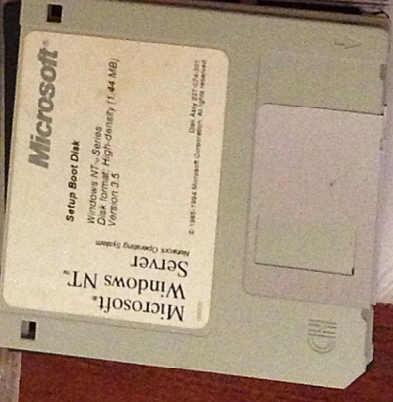
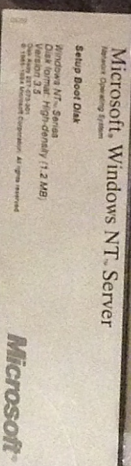
