Pursuant to the Patent and Trademark Office's Final Rule Setting and Adjusting Patent Fees, 78 F.R. 4211, 4234-4235 (Jan. 18, 2013), Petitioner Accord Healthcare, Inc., USA, ("Petitioner") requests a refund in the amount of \$16,800 to be paid to deposit account number 194880.

On June 14, 2013 Petitioner filed a Petition for *Inter Partes* Review with the PTO that was assigned case number IPR2013-00356. In accordance with the fee schedule specified in 37 C.F.R. § 42.15(a) Petitioner deposited an electronic payment in the amount of \$26,200 with the PTO at the time of filing of its Petition to cover associated fees.
