Patent Owner filed a motion in each of Cases IPR2013-00431 (Paper 36), IPR2013-00449 (Paper 35), IPR2013-00451 (Paper 39), and IPR2013-00468 (Paper 38) seeking to correct Patent Owner's response in each proceeding. In the motions, Patent Owner states that the responses contain two clerical errors: incorrect citations to Case IPR2014-00488, rather than Case IPR2014-00436, and an incorrect Table of Contents and Table of Authorities.
