Pursuant to the Patent and Trademark Office's Final Rule Setting and Adjusting Patent Fees, 78 F.R. 4211, 4234-4235 (Jan. 18, 2013), Petitioner Printing Industries of America ("PIA") requests a refund in the amount of \$14,000 to be paid to PIA.

On July 29, 2013, PIA filed a Petition for *Inter Partes* Review of claims 1-14 of U.S. Patent No. 6,611,349 that was assigned case number IPR2013-00474. In accordance with the fee schedule specified in 37 C.F.R. §42.15(a), PIA submitted payment by credit card in the amount of \$23,000 with the PTO at the time of filing of its Petition to cover the associated fees. PIA's payment consisted of \$9,000 in fees associated with PIA's Petition for *Inter Partes* review request, and further \$14,000 in Post-Institution Fees.

On December 30, 2013, the Patent Trial and Appeal Board entered judgment terminating the IPR2013-00474 proceeding prior to institution. Accordingly, PIA requests a refund in the amount of \$14,000 for the post-institution fees that it paid to the USPTO in connection with that proceeding and further requests that the refund be charged back to the credit card account used to pay the fees.
