Notice is hereby given, pursuant to 37 C.F.R. § 90.2(a), that Patent Owner Software Rights Archive, LLC hereby appeals to the United States Court of Appeals for the Federal Circuit from the Final Written Decision entered on January 30, 2015 (Paper 55), and from all underlying orders, decisions, rulings and opinions, including without limitation the Decision on the Institution of *Inter Partes* Review entered on February 3, 2014 (Paper 17).

In accordance with 37 C.F.R. § 90.2(a)(3)(ii), Patent Owner further indicates that the issues on appeal may include, but are not limited to:

1. Whether the Patent Trial and Appeal Board's claim construction was correct, including at least the claim terms "cluster link" and "candidate cluster link."
2. The Patent Trial and Appeal Board's determination of unpatentability of claim 14 of U.S. Patent No. 5,832,494 under 35 U.S.C. § 102; and
3. Any finding, claim interpretation, or determination supporting or related to those issues, as well as all other issues decided adversely to Patent Owner in any orders, decisions, rulings and opinions.

Simultaneous with this submission, a copy of the Notice of Appeal is being filed with the Patent Trial and Appeal Board. In addition, three copies of this Notice of Appeal, along with the required docketing fees, are being filed with the Clerk's Office for the United States Court of Appeals for the Federal Circuit.
