#### **ORDER**

Expunging Exhibit 1036
Denying Petitioner's Motion to Seal and
Denying Joint Motion to Enter Default Protective Order
37 C.F.R. § 42.54



Two motions are outstanding in this proceeding: (1) The parties' Joint Motion to Enter Default Protective Order (Paper 34); and (2) Petitioner's Motion to Seal (Paper 47). For the reasons stated in our Order entered February 10, 2015 (Paper 61, "Order"), neither of those motions is in condition for allowance. As we explained in that Order, the sole document filed in this proceeding, and alleged to contain confidential information, is Exhibit 1036. Order 2.

We directed the parties to confer to resolve whether it is necessary to maintain Exhibit 1036 in the record of this proceeding. Order 3. We further advised the parties that Exhibit 1036 shall be expunged from the record unless, within five (5) business days of the date of the Order, a paper is filed (jointly or individually) that shows cause why that exhibit should not be expunged. *Id*.

No paper having been filed in this proceeding, within the time period set in the Order, we *expunge* Exhibit 1036 from the record. The Joint Motion to Enter Default Protective Order is *denied*. Petitioner's Motion to Seal is *denied*.

## **ORDER**

It is

ORDERED that Exhibit 1036 is *expunged* from the record of this proceeding;

FURTHE ORDERED the Joint Motion to Enter Default Protective Order is *denied*; and

FURTHER ORDERED Petitioner's Motion to Seal is denied.
