The proceedings in *inter partes* reviews IPR2013-00567 and IPR2013-00568 have been terminated. IPR2013-00567, Paper 54; IPR2013-00568, Paper 55. These proceedings involved U.S. Patent No. 8,217,902 B2 ("the '902 patent"). The '902 patent is the subject of an *ex parte* re-examination (Control No. 90/012,869). On April 23, 2014, that re-examination was stayed pending termination or completion of the above-noted *inter partes* review proceedings. IPR2013-00567, Paper 17; IPR2013-00568, Paper 19.
