PATENT OWNER'S MOTION FOR OBSERVATIONS ON CROSS EXAMINATION OF PETITIONER'S REPLY DECLARANT HARRY BIMS



Pursuant to the Board's November 11, 2014 e-mail Order, Patent Owner submits the following observations on the October 17, 2014 cross-examination of petitioner's reply declarant Harry Bims (Exhibit 2029):

Observation #1. In Exhibit No. 2029, from page 79, line 10 to page 80, line 15 and from page 85, line 7 to page 87, line 4, Dr. Bims testified that he did not review the AX.25 specification that he used as a basis for his opinion about the control field 80 in Garrabrant. This testimony is relevant to the arguments on page 9 of Petitioner's Reply to Patent Owner's Response (Paper No. 45) and the testimony on ¶ 4 of Reply Declaration of Harry Bims, Ph.D. (Exhibit No. 1022), where Broadcom and Dr. Bims allege that Garrabrant (Exhibit No. 1002) discloses a control message (RNR) that sends a "lost" message to command a receiver to receive the next packet and move the receive window.

Observation #2. In Exhibit No. 2029, from page 65, line 18 to page 68, line 8, and in Exhibit No. 1022 ¶ 4, Dr. Bims testified that Garrabrant (Exhibit No. 1002) discloses a "lost" message command. This testimony is inconsistent with Dr. Bim's testimony at page 25, line 21 to page 26, line 2 of Exhibit 2028 in which Dr. Bim's testified that Garrabrant does not disclose a "lost" message command.
