Pursuant to 37 C.F.R. § 42.70(a), Patent Owner B.E. Technology, L.L.C. ("B.E.") hereby requests oral argument on whether claims 2 and 3 of U.S. Patent No. 6,771,290 are patentable over PCT International Publication Number WO97/09682.
