2. Any issues properly raised by Patent Owner, including Patent Owner's Response (Paper 30), Patent Owner's Contingent Motion to Amend (Paper 31), and Patent Owner's Reply to the Opposition to the Motion to Amend (Paper 36).
3. Any issues addressed by Petitioner, including Microsoft's Petition for *Inter Partes* Review (Paper No. 1), Petitioner's Reply to Patent Owner Response (Paper 33), and Petitioner's Opposition to Patent Owner's Motion to Amend (Paper 34).
4. Response to Patent Owner's arguments regarding the claim construction standard to be used in these proceedings, and relevance if any to the patentability issues raised by the original and/or amended claims.
5. Issues related to all exhibits filed in this proceeding.

6. Rebuttal to issues raised by the Patent Owner.

Petitioner requests permission to use audio/visual equipment to display demonstrative exhibits, including a projector and screen for PowerPoint or PDF slides.
