- 3. Claims 6 and 13 are invalid under 35 U.S.C. § 103(a) as unpatentable over Yuzuriha and U.S. Patent No. 6,359,304 ("Nakagawa").

Petitioners request the ability to use audio/visual equipment to display demonstrative exhibits, including the use of a projector and screen for a PowerPoint display.
