of October 24, 2014, during which we instructed the Parties to confer regarding: 1) whether a substitute Patent Owner's Response was required or desirable and 2) the most appropriate schedule for coordinating efforts in IPR2014-00110, IPR2014-00111, and IPR2014-00395 so that a single hearing could be conducted for all three proceedings.

The Patent Owner confirmed that it no longer believes that a substitute Patent Owner's Response is necessary. Based on discussions about potential modifications to the schedule in this proceeding and IPR2014-00110 and IPR2014-00111, we reschedule the oral hearing in IPR2014-00110, IPR2014-00111, and IPR2014-00395 to occur in a single session on January 27, 2015. The remaining due dates in IPR2014-00395 require alteration to support a hearing on January 27, 2015.
