Abstract

This draft documents the Web Cache Coordination Protocol (WCCP) V2.0. This protocol is used (a) to associate one or more routers with one or more web-caches for the purposes of transparent redirection of HTTP traffic, and (b) to allow one of the web-caches to dictate how the router or routers distribute transparently-redirection traffic across the associated web-caches.

This draft describes the interactions between one or more routers and one or more web-caches. It does not describe the interactions between a group of associated web-caches or those between a web-cache and a web-server.
