**PETITIONER REQUEST FOR REFUND**


Pursuant to the Patent and Trademark Office's Final Rule Setting and Adjusting Patent Fees, 78 Fed. Reg. 4211, 4233-34 (Jan. 18, 2013), Petitioner Sony Corporation ("Petitioner") hereby requests refund of the *Inter Partes* Review Post Institution Fee in the amount of \$14,000.00 to be paid to deposit account number 23/2825.

On December 5, 2013, Petitioner filed a Petition for *Inter Partes* Review of U.S. Patent No. 6,108,704 with the Patent Trial and Appeal Board that was assigned case number IPR2014-00230. 
