**EDWARDS LIFESCIENCES CORPORATION AND
MEDTRONIC, INC.'S JOINT MOTION TO TERMINATE
PROCEEDING PURSUANT TO 35 U.S.C. § 317 AND 37 C.F.R. § 42.74**

Pursuant to 35 U.S.C. § 317 and 37 C.F.R. § 42.74, Petitioner Edwards Lifesciences Corporation and Patent Owner Medtronic, Inc. (“the parties”) jointly request termination of the *Inter Partes* Review (“IPR”) of U.S. Patent No. 6,306,141 (**Case IPR2014-00362**) without prejudice to either party.

This IPR has not been instituted. Petitioner filed its petition on January 17, 2014, and Patent Owner filed its Preliminary Response on April 29, 2014. The parties have settled their dispute and have agreed to request termination of this IPR proceeding.
