PETITIONER'S REQUEST FOR ORAL HEARING

4. Why Patent Owner’s Motion to Amend (Paper 17) should be denied.
5. Any subsequent motion filed by Patent Owner.
6. Any other issue the Board seeks clarification on related to this proceeding.

Petitioner requests the ability to use audio visual equipment to display demonstrative exhibits, including the use of a projector and screen for PowerPoint display and an ELMO document camera/projector.
