Petitioners respectfully request that the Board recognize Mr. Luke L. Dauchot as counsel *pro hac vice* during this proceeding under 37 C.F.R. § 42.10. Petitioners seek Mr. Dauchot's assistance because of his experience assisting Petitioner Brose North America, Inc. on patent-related matters and his experience on the substantive and technical issues involved in this proceeding. Petitioners note that their lead and back-up counsel, Craig D. Leavell (No. 48,505) and Alyse Wu (No. 68,926) are registered practitioners.

I. STATEMENT OF FACTS

Mr. Dauchot is an experienced patent litigation attorney, with over 20 years of experience in discovery, jury and bench trials, Markman hearings, and appellate oral arguments in patent infringement matters. Mr. Dauchot is a member of the American Bar Association (Intellectual Property Law and Litigation Sections), American Intellectual Property Law Association, International Bar Association, Los Angeles Intellectual Property Law Association, and Judge Paul R. Michel Intellectual Property American Inn of Court (Executive Committee member). Mr. Dauchot's biography, including a list of representative cases, distinctions, publications, and professional activities, is attached as Exhibit A.

Mr. Dauchot was granted *pro hac vice* admission by the Office in multiple separate proceedings:

- *NuVasive, Inc. v. Warsaw Orthopedic, Inc.*, IPR2013-00206 (granted on May 15, 2013, Paper 10);

Mich) (the “co-pending litigation”). Mr. Dauchot is lead counsel for Petitioner Brose North America, Inc. in the co-pending litigation and, as such, has an established familiarity with the subject matter at issue in this proceeding. Petitioners wish to use Mr. Dauchot as counsel in this proceeding.

Therefore, there is good cause for the Board to recognize Mr. Dauchot as counsel *pro hac vice* during this proceeding.
