Under 37 C.F.R. § 42.70(a), and without intending to waive any issue not specifically identified, Patent Owner submits the following issues to be argued:

1. Failure to show unpatentability of claims 1-9, 11, 13-29, 38-45, 57-64, 66, 68-75, 77 and 79 for obviousness over Goodhand.
2. Failure to show unpatentability of claims 6, 10, 12, 21, 27, 30-37, 42, 46-56, 61, 65, 67, 72, 76 and 78 for obviousness over Goodhand and Padwick.
3. Any issue raised in Petitioners' or Patent Owner's Papers, including but not limited to the Petition (Paper 1), Patent Owner's response (Paper 17) or Petitioners' reply (Paper 23) and accompanying exhibits.
4. Rebuttal to Petitioners' presentation as to all matters.

Patent Owner requests that the Board provide audio-visual equipment to display demonstrative exhibits, including a projector to be connected to a laptop and a screen for displaying documents.
