On March 10, 2014, Apple Inc. (“Petitioner”) filed a Petition for *Inter Partes* Review of U.S. Patent No. 8,051,181 under 35 U.S.C. §§ 311-319 and 37 C.F.R. § 42.100 *et seq.* (“Petition,” Paper No. 1), seeking review of claims 1-29 of the ’181 patent. On September 16, 2014, the Patent Trial and Appeal Board issued a Decision Denying *Inter Partes* Review (Paper No. 18).
