**MOTION TO WITHDRAW AS COUNSEL  
PURSUANT TO 37 C.F.R. § 42.10(e)**

Pursuant to 37 C.F.R. § 42.10(e), Norman J. Hedges (Reg. No. 44,151), lead counsel in these proceedings for Petitioner Target Corporation, hereby moves to formally withdraw as counsel for Petitioner in this proceeding.<sup>1</sup>
